The Board met on March 26, 2015.

MAINTENANCE ITEMS COMPLETED:

- <u>Inner Docks</u> frozen waterlines at slips 65, 69, & 71 were repaired; piling ring at slip 20 was scraped/wire brushed and painted; end of dock walkway at slip 6 was rebuilt; handles on water spigots at slips 38 & 40, pole light bulb at slips 4 & 8, and 12 straps on water and power lines were replaced; electric cable covering was resecured at slip 53; water and power lines were checked for rodent damage (no damage found and traps were empty).
- <u>Outer Docks</u> pedestal light bulbs at slips 76, 80, 81 & 82 and new porch light fixture at Gazebo were installed; electric light at gazebo was repaired; deck boards were replaced; frozen/broken water pipes at fish cleaning station, water line break at slip 73, facuet leak at slip94 and water leak (under outer dock ramp) were repaired; 36 feet of railing near outer dock gazebo was re-stabilized..

<u>COMPILATION OF ARTICLES OF INCORPORATION & AMENDMENTS:</u> was completed and has been posted on the YC Website under "*Documents*". Now all of the documents (the Articles of Incorporation, the Declarations, the By-Laws and their amendments) have been compiled and placed on our website.


- **Volunteers needed**: when the weather gets nice....to pressure-wash the floating docks, pier and gazebo areas.
