- Do not move or block another trailer. (If there is a problem, contact the YC office)
- Tie up the wiring/chain around the tongue of your trailer, so it is not close to the ground. (Our grounds person will not trim underneath for fear of getting his weed trimmer caught, which will probably cause damage to both the wiring and weed trimmer)
- Check and refresh your trailer markings OFTEN. Sun quickly fades them.
